Arbor Hills Annual Meeting

The Arbor Hills Annual Meeting will be held at Clague Middle School Library on Thursday, October 25th from 7-9pm with sign in beginning at 6:30pm. Please place this date on your calendar and plan on attending or submitting your vote by proxy. We need attendance by proxy or presence of 35% (70) of unit owners. The 2013 Arbor Hills budget will be presented for vote, election for two positions on the board will take place and a review of 2012 will be presented.
